  - Plans in final design with estimated completion in Summer 2025

- **I-580 Overcrossings:**
  - \$250k in HSIP grant funding
  - Staff pursuing additional funding from ACTC CIP funds
- **Hopyard Rd/Owens Dr Intersection Improvements**
  - Construction began last week
- **Measure B/BB Projects:**
  - RRFB's installed at Vineyard Ave/Touriga Dr and Black Ave/Cedarwood Ln
  - K71 bollards installed on Stoneridge Dr from Trevor Pkwy to El Charro Rd
